Agency's – Specification of item(s)/services required:
 OCFS seeks two Program Managers and one Project Manager to provide contractual staff positions to the New York State Office of Children and Family Services (OCFS). The Program Managers' and Project Manager's work location will be 52 Washington Street, Rensselaer, NY 12144 and each manager will be assigned 37.5 hours per week M-F for the duration of the contract. The Program Managers and Project Manager will not work on holidays and/or when state offices are closed. See attached IFB document for full bid specifications.

The offerer(s) meeting Eligible Bidder requirements stated in the IFB, passing vendor responsibility review, and offering the lowest hourly rate will be awarded a contract for these services.

Bid price must include any and all costs associated with providing and delivering the services as specified herein, including a minimum salary paid to each Program Manager of \$61,270 per calendar year or a minimum salary paid to the Project Manager of \$75,000 per calendar year, with annual cost of living and/or performance-based increases included, plus fringe, applicable licenses, insurance, administrative, and all ancillary costs, including all administrative costs associated with locating, hiring and providing staff person(s) to fulfill the position for OCFS, if applicable. Travel expenses are NOT to be included in your hourly bid rate. Please refer to IFB Section 4.2 Price for additional information.

The base salary of these positions must have an annual cost of living adjustment (COLA) increase in subsequent years of the contract by adding to such base salary an amount obtained by multiplying the base salary being paid to these positions by a minimum of two (2) percent. This increase must be reflected in the bid price, which will remain firm for the life of the contract. The base salary for successive years will include the COLA increase from the preceding year.
