# Appendix M #3: Fraud and Abuse Control Activities and Inspections

#### I. Fraud and Abuse Control Activities

The County has implemented the Child Care Time and Attendance System and currently have 100% of providers in the system. The CCTA electronic submission began in February 2017.

Seneca County uses the following criteria and procedures to refer applications to FEDS. The County uses the following child care FED indicators:

working off the books(currently or previously), current application is inconsistent with prior case information, prior history of denial, case closings, over payments resulting from an investigation, ie: FEDS, EVER, no absent parent information, inconsistent employment information, documentation is questionable, self employed, but without adequate business records, unsure of own address

The referral procedures for FEDS begins with a referral from the Child Care subsidy worker reviewing the case with Supervisor(Workforce Development Youth Bureau Deputy Commisoner or Deputy Director) then submitting the referral form to the Principal Welfare Examiner or Commissioner. The Principal Welfare Examiner or Commissioner, then submits to the Fraud Investigator for fact finding. Once the fact finding is completed, the Fraud Investigator submits a written report to the Child Care Subsidy Worker. The report is reviewed to determine if there was an over grant. Once the determination is made, the case will be closed.

2. Describe the sampling methodology used to determine which cases will require verification of an applicant's or recipient's continued need for child care, including, as applicable, verification of participation in employment, education, or other required activities.

The district cannot use criteria such as the age of provider, the gender of provider, a post office box address, or evidence that the child lives in the same residence as the provider as indicators in drawing the sample.

The verification of employment information and other qualifying activities is done on all applicants and participants. Proof of employment is through payroll information such as pay stubs, and attendance sheets for other eligible activities. These are verified at 12 month redetermination.

3. Describe the sampling methodology used to determine which providers of subsidized child care services will be reviewed for the purpose of comparing the child care provider's attendance forms for children receiving subsidized child care services with any Child and Adult Care Food Program inspection forms to verify that child care was actually provided on the days listed on the attendance forms.

Random samples of two cases per month, 24 for the year for providers participating in the CACFP. Cases are selected alphabetically by last name of the parent that is requesting child care with no duplication of cases for the review

The Seneca County Department of Social Services will make the determinations as follows: Not Met: If the provider fails to clarify the discrepancies. Met: If the information regarding the indicated child protective report submitted by the provider to the parent/caretaker and the local district correlates with the information obtained from the local database check and the parent/caretaker still chooses to use the provider. When the local records check does not reveal a record wherein the person was an indicated subject of a child abuse or maltreatment report.
