This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

An SCR report stated that on 7/23/18, at approximately 9:30PM, the mother and father put their three children (ages 4, 3, and 2) to bed in a back bedroom. The parents then went to bed with their 1-year-old daughter in a front bedroom. At 11:48PM, emergency personnel was notified of a fire in the home. The mother, father, and 1-year-old child were able to escape the home. The father made multiple unsuccessful attempts to get into the back of the home to rescue the other children. The three oldest children were unable to escape the fire and their remains were found on 7/24/18 in the back area of the home. The father was a known user and manufacturer of methamphetamine and the mother was aware, making the fire suspicious in nature. The youngest child did not have any visible injuries.

Executive Summary

This fatality report concerns the death of three children (4, 3, and 2 years old) that occurred on 7/24/18, as a result of a fire in the family's home. There was a one-year-old female sibling who survived the fire.

Oneida County Department of Social Services (OCDSS) coordinated efforts with law enforcement upon receipt of the report. Law enforcement believed the fire started from wiring in an appliance and did not believe the fire was due to illegal activity. Law enforcement found no criminality in their investigation. The family had CPS history.

On 7/23/18, at approximately 9:30PM, the mother and father put the three oldest children to bed in a back bedroom of the home. The parents went to bed with the youngest child in the bedroom at the front of the home. Shortly before midnight, the mother awoke unable to breathe due to the smoke, and she saw fire at the back of the home. The parents took the youngest child out of the house and ran to a neighbor's home to call 911. The father made attempts to rescue the rest of the children at the back of the home but was unsuccessful. EMS arrived and transported the surviving sibling to the hospital. The surviving sibling was admitted and treated for second degree burns.

OCDSS obtained the fire investigation report completed by the Rome Fire Department which stated the cause of the fire was accidental. OCDSS received the final autopsy report; for all three children, the cause of death was smoke inhalation and the manner was accidental.

Home visits were made and OCDSS contacted multiple collaterals such as law enforcement, relatives, EMS, and the pediatrician's office. Burial assistance and grief counseling services were offered to the parents. OCDSS completed required reports and safety assessments accurately and on time and conducted a thorough investigation. The case was unfounded on 12/13/18 and remained opened for services.

LDSS Response

OCDSS initiated their investigation and coordinated efforts with LE upon receipt of the SCR fatality report which was received on 7/24/18. There was an open CPS investigation, received a month prior to the fatality. There was one surviving sibling; OCDSS observed this child in the hospital the day the report was received. The CW spoke to the source of the report and completed a CPS history check. The family had CPS history and was active in an open investigation.

OCDSS attempted to speak to the parents on this day but they refused and said they would speak to the CW at a later time. The CW provided the parents with referrals for bereavement services available to them and agreed to speak the following day.

On 7/25/18, the CW spoke with LE who said they believe the fire started due to an electrical wire in the family's washer or dryer, but it would take several weeks to confirm. LE said there was no indication of foul play. The CW spoke with a few relatives on this day who stated they had no concerns for the children in their parents care and denied the parents were using drugs or alcohol.

On 7/27/18, the CW visited the parents at the home, observed the fire damage and offered burial assistance. The parents declined the offer saying the funeral home was not charging them. The parents were still not ready to discuss the night of the incident during that meeting. The CW later interviewed the parents on 8/9/18 regarding the fire. The mother said the night of the incident, she woke up unable to breathe due to the smoke and saw there was a fire in the trailer. She said she screamed at the father telling him to get up and that there was a fire and he needed to get the children out of the back of the home. The father said he tried getting to the children but was unable to due to the fire. They said they took the youngest child out, ran to neighbors and called 911 at 11:48PM. Two fire departments and EMS arrived at the scene. The surviving sibling sustained 2nd degree burns to her back and arms and spent the night in the hospital. The mother followed up with the surviving sibling's medical appointments for the burns. The CW encouraged the parents to engage in grief counseling;



however, they were not interested at that time.

OCDSS obtained records from all hospitals and the children’s pediatrician’s office. The fire department declined to release records at that time. The CW spoke with EMS present the night of the incident and said they did not speak to the parents that night as it was a chaotic scene and they were rushing to get the surviving sibling medical treatment.

On 9/18/18, the CW made a home visit and observed a crib for the surviving sibling and smoke alarms in the home. The parents stated they were aware of safe sleep guidelines.

On 12/3/18, OCDSS received the fire investigation report which stated the cause of the fire was accidental. The final autopsy report was received on 12/12/18 and listed the cause of death for all three children as smoke inhalation with the manner being accidental.

The case was unfounded on 12/13/18 and was already open for protective services due to a previous neglect petition.
